Dear Friend,

The **12th Annual STL Cure Sarcoma 6K Run/Walk** will be held on Sunday, **October 12, 2025** at Creve Coeur Park in Maryland Heights, MO. Previously, STL Cure Sarcoma functioned under a larger organization. Under that organization and on our own, we have raised over **\$1.6 million** for sarcoma research. This is our second year as a small **501c3** organization. Proceeds from this event will benefit Dr. Brian Van Tine's sarcoma research at Siteman Cancer Center, as well as national sarcoma research grants that follow National Institutes of Health (NIH) guidelines. These grants will be distributed by the Musculoskeletal Tumor Society (MSTS).

Sarcoma is a rare cancer that originates in soft tissue or bone and accounts for 1% of cancers in adults and 15% in children. Sarcoma is currently treated with surgery or by a combination of surgery with chemotherapy and/or radiation. Unfortunately, there are more than 100 subtypes of sarcoma, and many sarcomas are totally resistant to all of these approaches—thus the extreme need for new therapeutic developments. Also of notable mention, Sarcoma's high presence among children and young adults means the average years of life lost per child dying of cancer is **sixty-seven** years. Funds raised from the **100% volunteer-led** STL Cure Sarcoma 6K Run/Walk will solely support research for the development of more effective treatment options that will create higher survival rates from this aggressive cancer.

Researchers dedicated to studying sarcoma, a rare and aggressive form of cancer, rely heavily on support from organizations like **STL Cure Sarcoma** to advance their work. The funds we've previously raised have been crucial in backing significant research projects, each one bringing us a step closer to comprehending this disease and, hopefully, discovering a cure. Despite recent medical progress, there remains a vast amount to learn. Your financial contributions will aid ongoing research, potentially leading to new treatment options for sarcoma patients battling for their lives.

On behalf of the Board of Directors, our dedicated volunteer race committee, and all sarcoma patients, both past and present, along with their caregivers and families, we extend our heartfelt thanks for considering our cause. 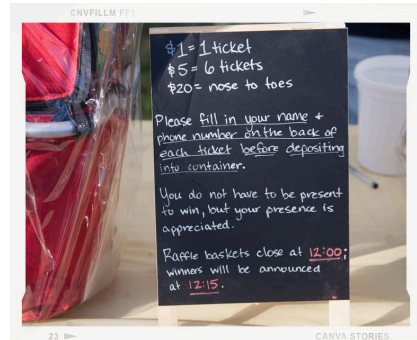

Our family friendly event includes Bounce Houses, Face Painting, and Balloon Art.



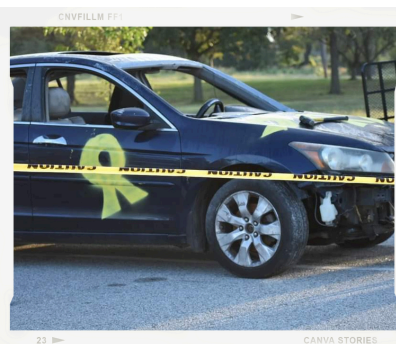
